Dr. Sabet received his PhD in Social Policy from the University of Oxford. Dr. Sabet was senior policy advisor to the Director of the Office of National Drug Control Policy under the Clinton, Bush and Obama administrations. Currently he is an adjunct professor at Yale University and adjunct professor and Director of the Drug Policy Institute at the University of Florida, School of Medicine. He is the president of Policy Solutions Group consulting with governments and non-governmental organizations on drug policy issues; and president and CEO of SAM Inc. (Smart Approaches to Marijuana).
